EXECUTIVE SUMMARY

1. Social and Institutional Aspects of the Project:

For better planning and Implementation of works under GPWDP, Revenue Village Committee (RVC) has been formed in each Project villages across all the four divisions.

2. Water and Watershed Management Committees (WWMCs) & Revenue Village Committees (RVCs):

In the Project GPs, out of 203 GPs, a total of 188 WWMCs were formed which is 93% of total WWMC to be formed in project area and out of 402 RVCs a total of 334 were formed which is 83% of total RVCs to be formed in the project area.

3. Village Motivators:

Total 375 Village Motivators have been appointed in four Divisions.

4. Women Aam Sabhas:

Participation of Women in Implementation of AWPs:

During this fiscal, the FNGO conducted 347 women Aam Sabhas in the Round-I. The representation of households by women in these meetings was 60% while during Round-II, 348 women Aam Sabhas were organized where the representation of households by women was 63%.

Progress of Women's Proposals:

Against total 2620 women proposals raised during WAS meetings conducted during the process for preparation of GPWDPs, 2040 were incorporated in the respective GPWDPs of these Gram Panchayats. Almost all the proposals have been addressed in case of PMU and Pauri Division. Overall, 2510 proposals have been addressed across all the divisions. Of the remaining proposals, 6 proposals will be addressed during the FY 2020-21. However, 104 proposals cannot be addressed through the Project as the structures/ activities proposed under these proposals either already exist in the village or cannot be addressed as the basic infrastructure such as water source/ Panchayat land does not exists in the village.





5. Vulnerable Individuals and Groups:

During this financial year (2019-20), total 472 Individual and 28 Group IGAs were supported under the project benefitting 637 vulnerable households. A total of 637 vulnerable beneficiaries were funded with Rs. 1,65,12,900 for establishing their IGAs during the year 2019-20.

Vulnerable Individuals:

Progress : Subsequent to Social Mobilization of vulnerable households, the FNGO team facilitated the process and identified and prepared proposals for 472 Vulnerable Individuals across all the four divisions against a target of 406 Vulnerable Individual beneficiaries.

Gender-wise Analysis of Vulnerable Individuals: This year FNGO financed 472 Individual beneficiaries of which 203 were female beneficiaries from vulnerable households.

Sectoral Analysis of Vulnerable Individuals: Going by sectoral progress of Vulnerable Individuals, 80% have opted for livestock activities for their alternative Carpenter, blacksmith, tailoring, etc..

Vulnerable Groups

Progress: Project had set the target of 40 Vulnerable Groups (VGs) across all the four Divisions. However, against the target only 28 groups could be formed.

Gender-wise Analysis: Going by divisions, Pauri has topped the list of women participants in Vulnerable Group with 64% women members, followed by 36% in Tehri.

Sectoral Analysis of Vulnerable Groups and their Participation in the **Project:** Mushroom, Tent House and Catering remain the activity of major choice by most of the groups with 36%, 25% and 21%, respectively opting for these activities.

Cumulative Progress of Vulnerable Individuals and Groups:

Overall Progress of Vulnerable Groups/Individuals:

A total of 2,299 Individual IGAs and 251 Group IGAs have been supported under the Project benefitting 3743 households. A total grant of Rs.8,80,10,080.00 has





been distributed to vulnerable households till 31st March 2020. In case of Vulnerable Individuals, Rs. 6,55,88,180.00 has been invested on 2,299 members by the end of March 2020, across all the Divisions. The average amount invested on each Individual beneficiary comes to Rs. 28,529.00. Similarly, in the case of 251 Group IGAs which were funded from the Project to the tune of Rs 2,24,21,900.00 till March 2020 benefitting overall 1444 members.

6. User Groups:

With a view to promoting the concept for maintenance and upkeep of assets created by the project in the villages, 186 User groups were formed during the financial year ending 31st March 2020 in addition to 333 groups formed till the previous year across all the four divisions. Thus, the total number of User Groups formed under the project in four divisions of Garhwal Region has reached 519.

Total Rs. 25,63,777.00 have been deposited into User Group accounts till financial year ending 31st March 2020 with Tehri Division topping the list with Rs. 11,47,610.00.

7. Social Audit - Participatory Monitoring & Evaluation

During FY 2019-20 PME Round-5 was initiated in Garhwal Region w.e.f. 2nd April 2019 and was completed in the month of July 2019 covering 199 GPs across the four Divisions.



(I) Background:

In the State of Uttarakhand water, agriculture, forestry, energy, chekcing the incidence of migration and increasing employemnt are some of the issues which form the core strartegy for the future growth. Over three-fourth of the total population in the state depends upon agriculture for its livelihood and most of the landholdings are small and scattered. Poverty is a serious problem with 36.5 percent of the State population living below the poverty line. Situation is even worse in mountain areas of the state where around 38.5 percent of the population is living below the poverty line (Source: Project Operation Manual, UDWDP Phase II). Uttarakhand Decentralized Watershed Management Project (UDWDP) Phase II is being implemented by the Gram Panchayats since July 2014. UDWDP Phase II hired Society





of People for Development (SPD) as FNGO in four divisions of Garhwal region, namely, Pauri, Tehri, Dehradun and PMU (MWS), Raipur w.e.f. March 2015.

Focus of the project is to develop and enhance productivity of rainfed areas by adopting participatory watershed management appraoch in 202 Gram Panchayats (GP) and 401 Revenue Villages (RV) in these four Divisions of Garhwal region spread over 6 Development Blocks of 3 districts having the problem of soil erosion, poverty and lack of infrastructure facilities. The intervention area covers over 30 Micro Watersheds (MWS) in Tehri, Pauri, Dehradun and PMU MMWS in Raipur division. As per the baseline survey conducted in 2015, there are 18403 households across these four divisions of which 7062 households are in Tehri Division, 5165 in Pauri Division, 5481 in Dehradun Division and 695 in PMU MMWS, Raipur.

(II) Project Development Objective:

The Project Development Objective (PDO) is to improve the productivity potential of natural resources and rainfed agriculture with participation of communities in selected microwatersheds in the State of Uttarakhand.

The Project implementation envisages a decentralized and participatory approach with financial autonomy to the PRIs which are legal insititutions under 76th amendment. Focus of the Project is to enhance community participation in watershed development and management with a view to improving and strengthening administrative capacities of GPs for efficient delivery system. Institution building at the community level is the prime focus of the Project with FNGO forming various small community groups for smooth functioning of the Project at village and GP level ensuing equitable participation by all groups, especially the landless and women who rely disproportionately on common-pool resources for fodder, fuel and other forest products. CBOs in the Project area have been consolidated and strengthened through various capacity development initiatives involving trainings, exposure visits and workshops.

Developing backward and forward linkages between the farmers and market, the FNGO has facilitated the capacity development plan for various community groups such as FIGs, UGs, VGs, and FFs of Gramya-I. While developing backward and forward linakages, FNGO facilitated awareness generation and information disseemination on improved varities of seeds, demostration of technology and conducting market survey products of FIG across all the four Divisions. To improve the sale of their products, the FNGO mobilized and motivated the farmers and ensured their participation in various exihibitions for display of their





products at stall for sale. These exihibitions help them in providing them a platform display, sale branding of their products as also help inculculcating in them businessmanship besides developing their understanding on market demand and pricing of products. These platforms have been instrumental in opening up new avenues of livelihood for the village community.

(III) Result Framework:

The achievement of project development objective will be determined through the following key indicators using baseline survey data conducted during the first year, with that of mid-term assessment and final evaluation:

- Improved natural resources conservation (NRC) outcomes in target MWS
- Increased productivity of arable land
- Percentage increase in income through project intervention.
- Direct project beneficiaries

(IV) Project Components:

- Social Mobilization and Participatory Watershed Planning
- Watershed Treatment and Rainfed Area Development
- Enhancing Livelihood Opportunities
- Project Management

(V) Safeguard Policies Applicable to the Project:

(i) Environmental Assessment:

During the planning phase of the Project, FNGO has facilitated the process and experts discussed on the basis of it social and environmental impatcs of activities which were proposed by the villagers. It help to ensured the environmental and social soundness and sustainability of investment project. The result of that they supported integration of environmental and social aspects of project in the decision-making process during the preaparation of GPWDPs. When implementating the AWPs the social and environmental aspect of activities were kept in mind.

(ii) Natural Habitats:

Promoting environmentally sustainable development by supporting the protection, conservation, maintenance, and rehabilitation of natural habitats and their functions have been the key intervention areas of the project. To achieve this, the FNGO and MDT teams discussed the benefits of environmently susutainable activities at RV





level during the PRA excersie to prioritize the problems and priorities of village community. This facilitated the process for implemention of AWPs across all the four Divisions.

(iii) Pest Management :

This focused on minimizing and managing the environmental and health risks associated with indiscriminate use of pesticides and promote and support safe, effective, and environmentally sound pest management methods. FNGO and MDT teams regularly motivated households on use of compost and vermi compost in the fields. To achieve this objective, trainings and exposure visits to the sites where farmers are using bio fertilizers and bio pests were facilitated. Various farmers have adopted the bio pest methods for control of insecticides.

(iv) Physical Cultural Resources (PCR) :

Assisting in preserving PCR and in averting their destruction or damage is an important activity of the project. PCR includes resources of archeological, paleontological, historical, architectural, religious (including graveyards and burial sites), aesthetic, or other cultural significance.

(v) Involuntary Resettlement:

The project also focuses on avoiding or minimizing involuntary resettlement and, where this is not feasible, assist displaced persons in improving or at least restoring their livelihoods and standards of living in real terms relative to pre-displacement levels or to levels prevailing prior to the beginning of project implementation, whichever is higher.

(vi) Indigenous People :

Designing and implementing projects in a way that fosters full respect for indigenous peoples' dignity, human rights, and cultural uniqueness so that they (1) receive culturally compatible social and economic benefits, and (2) do not suffer adverse effects during the development process. To sensitize indigenous people, the FNGO team facilitated the process for transhumant population and provided support in organizing camps for this purpose. The transhumant population or Gujjar stayed in Thatyur, Nainbag, Aglar bridge, Vikas Nagar and Sahiya during their movement.

(vii) Forest:

The project is dedicating to Realizing the potential of forests to reduce poverty in a sustainable manner. The application and mitigation of all the safeguard policies are





covered in the Environmental & Social Management Framework (ESMF) applicable to the Project.

(VI) Role of FNGO:

The Field NGO is playing a significant role in implementing participatory watershed development projects in planning, implementation, monitoring and evaluation activities of the project. Field NGO (FNGO) ensured and facilitated the participation of village communities in project activities. There is social structure, attitude and dynamics pravelent in the community for participation in implementation of participatory project. The FNGO successfully filled this gap by provided support of qualified and professional staff in the project villages in Garhwal region in Gramya-II. The main roles of FNGO in Uttarkhand Decentralized Watershed Development Project Gramya-II is as follows:

(i) Participatory Watershed Development planning & Implementation:

Uttarakhand Decentralized Watershed Development Project (UDWDP) Gramya-II is a community demand driven project. Therefore, the FNGO contacted and mobilized the villagers and generated awareness among them by disseminating information on project activities through rapport building; awareness generation meetings; personal interactions; printed material on UDWDP; workshops;p trainings and exposure visits within and outside the state across all the four Divisions, namely, Dehradun, Tehri, Pauri and PMU MMWS in Raipur.

(ii) PRA, Awareness Building and Community Mobilization:

After creating a conducive environment at the village level, the FNGO facilitated the process of PRA and preparation of GPWDPs. FNGO intitiated the process of Participatory Rural Appriasal under which various PRA exercises were conducted for identification of their problems to enable participatory bottom up planning process with technical support by MDT. Plans were collected from the RVCs and the same were approved in case of 201 GPWDPs during second year (2016) of the project. One Gram Panchayat, namely, Mothi in Dehradun Division Vikasnagar has been added during this year (2018-19). Due to some reciprocal dispute among the villagers, the GP could not taken up under the Project earlier. This year FNGO with MDT support has initiated PRA exercise for planning and preparation of GPWDP. Proposals have been collected and sreened as per the norms of ESMF and incorpoarated into the GPWDP. The GPWDP has thus been prepared and approved. Women Aam Sabha has been organised and their proposals have also been





incorporated in the GPWDP. Wealth ranking of households has been done by the FNGO and plan for vulnerable households has been prepared in accordance with the demand of vulnerable households. Tent house has been proposed by the VG for alternative livelihood of group members. The FNGO field staff along with MDT memebrs are disseminating project related key information amongst the community and encourage them for active participation in implementation of GPWDP as well as in identification of vulnerable households using wealth ranking data of the village. Apart from this, the vulnerable households who did not show inclinationm to work in groups have been selected as individual beneficiaries for grant under Vulnerable Group Fund (VGF). Vulnerable households have been organized into groups by the FNGO field team and have faciliated initiation of their income generating activity. Further, the FNGO also generated awareness as to the need for soil conservation, water resource management, ESMF and other NRM interventions across all the four Divisions, i.e., Dehradun, Tehri, Pauri and PMU, MMWS, Raipur of Grahwal region.

(iii) Gender Issues:

FNGO team mobilized the local community, especially women folk, and discussed with them the diverse issues related to project. As a result of mobilization, women and men equally participated in meetings and other project related activities. Regular efforts and contacts with the community members has resulted in building up of trust between project staff and community helping in strengthening of project implementation process. Consequent upon awareness generation activities, women have developed an understanding about project activities and have build up a confidence in them, thus enabling them have their say regarding project activities and interventions. As a result of rapport building among project staff and the community, the FNGO field staff has been able to promote institution building at GP and RV level with the formation of several groups as per project requirements.

Addressing gender issues by promoting women participation in project activities had been the key focus area of project interventions, which has been well addressed by the FNGO by ensuring more than 50% representation of households by women in WAS and other project meetings. To begin with, owing to regular persuasion by the FNGO field staff, women started participating in village level meetings and gradually they began to participate in discussions and made proposals for being incorporated in GPWPD. Mobilization of women had been constantly taken care of by the project field team thus encouraging the women to participate in project meetings, trainings, workshops and exposure tours. Participation of women in project meetings, which initially stood at less than 5% in WAS meetings, has reached more





than 50% in terms of representation of households. As a matter of fact, the participation of women in WAS and other project meetings is between 35 to 40 percent, whereas going by representation of households by women in these meetings, the same had been around 60% during the year 2019-20. This has been invariably maintained in the project meetings, be it WAS, AWP or PME meetings.

FNGO, SPD is providing services in the project areas under the social component in Garhwal region and covered 203 Gram Panchayats and 402 Revenue Villages. Besides this A team of social staff from Project Director Level to unit level and mobilizing the villagers. And doing work as integal part of Multidisciplinary Team (MDT) in close coorperation in each Division.

(iv) Local Institutions Development and Capacity Building:

In addition to this, FNGO organized women into groups all across the four Divisions and assisted in the conduction of women Aam Sabha in each Revenue Villages of the project. During the planning phase of Gramya II, the women Aam Sabha in the four Divisions was organised on monthly basis and their proposals were taken in the general meetings of women. After scrutiny of proposals in accordance with the norms of ESMF and demands of the women as well as the villagers (in case of fodder plantation), these proposals were incorporated in the Annual Work Plan of respectives Gram Panchayat. Besides these, FNGO team also worked for institutional building and assisted in the formation of User groups for maintenance of water structures constructed by GP.

(v) Sustainability of Institutions:

During the year 2019-20, the FNGO team worked towards ensuring sustainability of Institutions. Various groups such as VGs, UGs, FIGs and FFs of Gramya II, were formed in all four Divisions. The FNGO team assisted in organizing vulnerable households into groups to initiating alternative income generating activities and assisted in maintaining their records. Similarly, in case of User Groups, the FNGO team motivated the User Group members to deposit their contribution for maintenance of water structures for their long term sustainability.

(vi) Micro Credit and Micro Enterprises Development:

FNGO keeps on motivating the Vulnerable Groups and Individual beneficiaries on regular basis to run their IGAs and save money from their earnings after bearing their family expenses. Some of the VGs have deposited their earnings made from





their collective IGAs into their groups accounts. Beside, FIGs have been formed at the Ravenue Village levels for promoting various agricultural activities.

FNGO motivated and mobilized these groups for saving and generated the corpus fund of FIGs with contribution by members. The FNGO also took the initiative towards developing banking habits among FIG members (FIGs) with the help of their corpus fund. Various FIGs are involved in micro loaning on minimal interest rates. The interest rates to be charged from the members have been decided by the group members themselves.

Similarly, in the case of User Groups, FNGO field staff supervise their record keeping through during their monthly meetings and motivate them to deposit their contribution into User Group accounts.

(vii) Networking and Market Linkages:

FNGO team also facilitated the process for marketing of products prepared by the groups to enable them fetch a better price. Various FIGs across the four Divisions are engaged producing pickles, Juice, Sauce, Ghee and value addition of local products like pulses etc. and selling them in the market.

(viii) Process Documentation:

To assess the impact of project interventions, the FNGO team captured the data from various project activities like compost making, vegetable cultivation, poultry, dairy farming, plantation and documented them as case studies and success stories. During the year, a number of case studies were documented and published in the monthly progress reports from time to time.

(ix) MIS Handling:

Management Information System is a crucial component of the project. FNGO team maintained the records of data regarding social mobilization of various activities at their office in the form of reports, presentation and case studies.

Due to low potential for collective working, the target for formation of VGs was revised downwards. In all the four Divisions, 2,299 Vulnerable Individual HHs have benefited from VG Fund till March 2020. By the end of March 2020, 251 VGs were formed in all the four Divisions benefitting 1444 HHs from this activity. In all the four Divisions, 3743 HHs were benefitted.

Qualitative Review of Institutions in Project Area

(I) Social and Institutional Aspects of the Project:

A decentralized approach towards Planning, Implementation and Monitoring of the Project and setting up of Gram Panchayat as main institution is the key feature of the Project. For better planning and Implementation of works under GPWDP, Revenue Village Committee (RVC) has been formed in each Project village across all the four divisions.

(II) Water and Watershed Management Committees (WWMCs) & Revenue Village Committees (RVCs):

With the swearing in of newly elected Gram Pradhans, new Gram Panchayats have already taken shape in all the units of the Division. Gram Panchayats being the implementing agencies for Watershed Development Plan, their orientation towards implementation of Gram Panchayat Watershed Development Plan (GPWDP) becomes mandatory.



FNGO Facilitators provided support in constitution of WWMCs and RVCs in the project area, as a result of which, out of 203 GPs, a total of 188 WWMCs were formed which is 93% of total WWMC to be formed in project area and out of 402 RVCs a total of 334 were formed which is 83% of total RVCs to be formed in the project area.

(III) Village Motivators:

One-woman motivator is designated in each Revenue village, except in case of uninhabited Revenue Villages. Thus, the total number of Village Motivators in four Divisions is 375. The role of these Village Motivators is to mobilize the village community, especially women and ensure their strong participation in Project activities at their village through Women Aam Sabhas.



For capacity building of these Village Motivators, Pauri Division organized workshops during each month with the support of FNGO Facilitators. It was observed that average 88% of Village Motivators participated in these workshops. Tehri Division also organized 3 workshops for these Village Motivators during each month of the year at their Project unit which were attended by about 85% of the Motivators. Similarly, Dehradun Division also organized 3 workshops for these Motivators in their respective Project units during each





month of the year which were attended by 92% of the Motivators. PMU, Raipur organizes one workshop for Village Motivators every month and around 96% of the Motivators participate in these workshops.

Besides this, the expectation from Woman Motivators is to facilitate the process for formation of livelihood groups comprising vulnerable households and providing all possible support to them. Although, most of the Motivators live outside the villages (other places), it has been observed that in village level programmes, meetings and visits they come to their villages and try to ensure complete participation of village communities and provide necessary support in identification and formation of livelihood groups comprising Vulnerable households in the Project villages across all the Divisions.

(IV) Women Aam Sabhas:

Participation of Women in Implementation of AWPs:

During this fiscal, the FNGO conducted 347 women Aam Sabha in first round in project villages across four divisions. The representation of households by women in these meetings was 60% while during Round-II, 348 women Aam Sabhas were organized where the representation of households by women was 63%.









Progress of Women's Proposals:

Against total 2620 women proposals raised in WAS meetings conducted during the process for preparation of GPWDPs, 2040 proposals were incorporated in the respective GPWDPs of these Gram Panchayats. Almost all the proposals have been addressed in case of PMU and Pauri Division. Overall, 2510 proposals have been addressed across all the divisions. Of the remaining, 6 proposals will be addressed during the FY 2020-21. However, 104 proposals cannot be addressed through the Project as the structures/ activities proposed under these proposals either already exist in the village or cannot be addressed as the basic resources such as water source/ Panchayat land does not exist in the village.

Break-up of Women's Proposals:

As can be seen from the table below, of total 2620 proposals made by women, maximum related to agriculture, animal husbandry and capacity building activities. Number of activities were also focused on environmental issues, such as soil erosion, water conservation, fuel, fodder, energy conservation, etc. However, most of the proposals raised by women and incorporated into GPWDPs have been resolved.

(V) Vulnerable Individuals and Groups:

During this financial year (2019-20), total 472 Individual and 28 Group IGAs were supported under the project benefitting 637 vulnerable households. A total of 637 vulnerable beneficiaries were funded with Rs. 1,65,12,900 for establishing their IGAs during the year





2019-20. The progress against the Indicators of Vulnerable Groups and Individuals and their livelihood activities directly contributed to the income of these Groups and Individuals. The progress of Vulnerable Group and Individual activities undertaken during this fiscal and their cumulative progress has been described below in detail.

(i) Vulnerable Individuals:

With the view to increasing participation of vulnerable households in the implementation of Project, FNGO conducted meetings of vulnerable households at village level to motivate and mobilize them to take up Income Generating Activities (IGAs) for their social and economic upliftment across all the four Divisions of Garhwal region during the financial year 2019-20.

Subsequent to Social Mobilization of vulnerable households, the FNGO team facilitated the process and identified and prepared proposals for 472 Vulnerable Individuals across all the four divisions against a target of 406 Vulnerable Individual beneficiaries. These Individual beneficiaries are actively participating in other Project management activities.

Achievement: This year the target under the Vulnerable Individuals for all the four Divisions was fixed at 406 for the year. In certain cases, it becomes a bit difficult to identify likeminded people to come together and form a group to take up IGA collectively. FNGO teams analyzed the ground realities of vulnerable households where people were hesitant to take up IGA collectively and it was found that the individual approach for taking up a venture was a good option for them. Therefore, the target for Individual beneficiaries was revised upwards and 472 Individuals were funded, thus achieving a target of 116%. All the selected beneficiaries have received funding through their Gram Panchayats and have initiated their IGAs.

Gender-wise Analysis of Vulnerable Individuals:

Addressing gender in participation and decision making in Project planning and Implementation by the community is one of the key features of the Project. Participation of vulnerable sections of the society, especially women in all project activities is mandatory. This year FNGO financed 472 Individual beneficiaries, of which 203 were female beneficiaries from vulnerable households. The details of gender wise status of Vulnerable Individuals are given in the table below:

Gender wise status of Vulnerable Individuals (FY2019-20)

Achievement: The above table shows gender-wise analysis of vulnerable Individual beneficiaries funded during the year for initiating their alternative income generating activity. It is a significant achievement that out of total beneficiaries across all the divisions 42% were poor women selected for being funded for establishing alternative livelihood for their families. Pauri division topping the list financed 82 poor women out of 203 vulnerable Individuals, which is 50% of the total Female beneficiaries and this is a remarkable achievement followed by 47% females in Tehri Division. Dehradun Division, however, reported the lowest number of female beneficiaries with 35%. However, overall funding to





43% women beneficiaries points towards women empowerment through Gramya-II, whereby women have shown keen interest in initiating their own livelihood activities as individual beneficiaries.

Sectoral Analysis of Vulnerable Individuals:


Going by sectoral progress of Vulnerable Individuals, 80% have opted for livestock activities for their alternative livelihood. These being the traditional activities for generating cash income, the people appear to show interest in these activities. The modern technical professions are in the lower strata of IGA sectors. However, other traditional professions, such as Carpenter, blacksmith, tailoring, etc. also have a good percentage of people showing their interest in opting for these skill based activities in different traditional livelihood skills/options. The sector-wise analysis of Vulnerable Individual activities is given in the Table below:

(ii) Vulnerable Groups

Progress:

Just as in case of Vulnerable Individuals, FNGO field team also mobilized the vulnerable households in the project area to take up group activities for their livelihood. Project had set the target of 28 Vulnerable Groups (VGs) across all the four Divisions.



FNGO teams discussed IGA options with vulnerable households in the project area. It was found that it is a bit difficult to identify likeminded people to form groups of vulnerable





households to take up income generating activities collectively. However, the FNGO team made its best efforts in this direction motivating and mobilizing the eligible households to come together to establish collective business ventures. The success was achieved with the formation of only 28 vulnerable groups against the annual target of 40, which falls much below the target. The details of vulnerable groups who received funds under vulnerable group fund are given below:

Status of Fund Relased to Vulnerable Groups for the Year 2019-20

Achievements: The above table shows the progress and achievement against the funding of Vulnerable Groups during the year 2019-20. The achievement against this component of the project is not very encouraging and shows 70% achievement of target for the year. It was observed that people generally do not show much interest in collective working and prefer working individually. However, a few HHs who volunteered to work collectively were formed in groups.

Gender-wise Analysis:

As enumerated earlier, the activities being implemented by Gramya-II show the empowerment of women with more and more women coming forward to take up income generating activities either individually or collectively. As in the case of Vulnerable Individuals, women in Vulnerable Group activities have also shown remarkable turnout with 74 women participating in collective income generating activities out of total 165 beneficiaries of vulnerable groups across four project divisions. Going by divisions, Pauri has topped the list of women participants in Vulnerable Group with 64% women members, followed by 36% in Tehri. The higher incidence of men migration in Pauri District could be one valid reason in case of women taking the lead in income generating activities. In Dehradun Division, agriculture had been the major source of income of households but the scenario seems to have changed in the recent past with several families migrating to the plains in search of jobs and education for their children, thus weakening of interest in agriculture activities. Thus, several women seem to have come forward to take up alternative livelihood for generating cash income for their households. Catering and tent house are the major focus activities in case of group ventures providing good source of collective livelihood to vulnerable women. This has also helped the women to overcome





their hesitation in taking up alternative income generating activities. Details of gender-wise analysis across four Divisions of the Project are given in the table below:



Sectoral Analysis of Vulnerable Groups and their Participation in the Project:

In case of activities initiated with project support from venerable grant fund by Vulnerable Groups in the project area, Tent House and Catering remains the activity of major choice by most of the groups with 37% and 31%, respectively opting for these activities. This is owing to the absence of such facilities in the village locations and its demand potential during marriage season. This is followed by another preferred option of Band party and Dhol-Damau (local musical instruments), which again has a potential during marriage season, with 17% groups opting for the same. The details of sector-wise analysis of group IG Activities of this year (2018-19) have been given in table below:

(iii) Cumulative Progress of Vulnerable Individuals and Groups:

Socio-economic Profile of Households:

During last four years (from April 2015 to March 2020), Vulnerable Groups/Individuals have become a big economic force in the Project villages across the four project Divisions. According to the baseline information of PRA during planning phase and GPWDP of 203 GPs of four Divisions, there are 18403 households. To assess the socio-economic status of these households, wealth ranking was done by the community members during PRA who categorized these households into three Income Groups, i.e. Higher Income Group (HIG), Middle Income Group (MIG) and Lower Income Group (LIG). The criteria for determination of the Income Groups was decided by the community and was village and locality specific.

As a result of Wealth Ranking in all the RVs (Revenue Villages) of 203 Gram Panchayats (GPs), 8056 households were found to be in Lower Income Group across all four Divisions, i.e., 2075 Pauri (40.17%), 3085 Tehri (43.68%), 2643 Dehradun (48.22%) and 253 PMU, Raipur (36.40%). In Dehradun Division, majority of households were living under poverty conditions whereas this figure was the lowest in case of PMU, Raipur.

Similarly, in case of Higher Income Group, PMU, Raipur at 24.46% households has the largest percentage of this category, with Tehri being the lowest with 17.83%. Whereas, Pauri and Dehradun Divisions have 19.50% and 19.52% Higher Income Group households, respectively. The Middle Income Group stood at 37.17% in all the four divisions put together with 6841 households in this category. Details of three economic categories of households across the four Divisions are given in the table below:

Economic Profile of Households

Overall Progress of Vulnerable Groups/Individuals:

Main focus of the Project is on socio-economic upliftment of 8056 households which were identified in the Lower Income Group (LIG) under the Project through PRA across four Divisions during planning phase. Hence the, FNGO focused its attention on involving these households in Income Generating Activities which are economically viable and locally feasible and also beneficial for their families. A total of 2,299 Individual IGAs and 251 Group





IGAs have been supported under the Project benefitting 3743 households. A total grant of Rs.8,80,10,080.00 has been distributed to vulnerable households till 31st March 2020.

In case of Vulnerable Individuals, Rs. 6,55,88,180.00 has been invested on 2,299 members by the end of March 2020, across all the Divisions. The average amount invested on each Individual beneficiary comes to Rs. 28,529.00. Some individual beneficiaries have been funded recently and their IGAs have not yet started generating income.

Similarly, in the case of 251 Group IGAs which were funded from the Project to the tune of Rs 2,24,21,900.00 till March 2020 benefitting overall 1444 members. As in the case of vulnerable individuals, some vulnerable groups have also received fund and have not initiated their IGA. An average fund disbursement to Vulnerable Group and Individual households during the project period is given in the table below:

(VI) User Groups:

The project has a mechanism of maintaining the assets, mainly water structures, created under the project, through a group of people enjoying the benefits of such assets. These groups are called User Groups, who collectively avail the benefits of these assets and contribute financially to the corpus of their group towards user charges for maintenance of their assets for its longevity and sustainability. With a view to promoting the concept for maintenance and upkeep of assets created by the project in the villages, 186 User groups





were formed during the financial year ending 31st March 2020 in addition to 333 groups formed till the previous year across all the four divisions. Apart from this, the Field team facilitated the process for opening of Bank Accounts of these User Groups and depositing their contribution in the same.



Formation of User Groups:

In addition to those previously functional 333 User Groups across the four Divisions, 186 new User Groups have been formed during the year 2019-20 for maintenance and proper use of assets created during the financial year ending 31st March 2020. Thus, the total number of User Groups formed under the project in four divisions of Garhwal Region has reached 519. Cumulative progress for formation of User Groups is given in the table below:



Going by asset-wise formation of User Groups, it can be seen that 57% of the User Groups formed across the four Divisions are for Irrigation Tanks, followed by Irrigation pipeline 15%, Irrigation channels 14% and Village Ponds 4%.

Status for Opening of Bank Accounts:

As stated earlier, the User Groups formed for use and maintenance of community assets are motivated by the FNGO field staff for making their contribution into their groups' corpus fund and ensure that the same is deposited into the bank accounts opened for the purpose. To ensure this, total 284 bank accounts have been opened with regard to the User Groups formed till 31st March 2019. The Unit-wise details of bank accounts opened and the contributions made therein, are given in the table below.

From the table, it can be seen that total Rs. 25,63,777.00 have been deposited into User Group accounts till financial year ending 31st March 2020 with Tehri Division topping the list with Rs. 11,47,610.00, as per the details given in the table above.

VII) Social Audit - Participatory Monitoring & Evaluation

Uttarakhand Decentralized Watershed Development Project, Phase-2 being a community demand driven Project is implemented by Gram Panchayats, with due involvement of local communities in planning and implementation of the Project. The FNGO supports in preparation of Gram Panchayat Watershed Development Plan (GPWDP) through bottom up approach of planning and with active participation of stakeholders in their respective





GPWDP planning and implementation. The Project is administered and implemented by the Gram Panchayats. Therefore, it becomes mandatory to involve wider range of stakeholders at micro level for Monitoring and Evaluation of project through a more participatory approach.



PME is an effective tool in assessement of change brought about by implementation of Project activities and is intended at involving village community in this process. Conventionally, this process was usually done by external experts in the project against set indicators. But in adoption of a complete participatory approach, this process has been introduced for complete community involvement for tracking, monitoring and evaluating the project activities. Participatory Monitoring & Evaluation (PME) is the process of social audit, which involves project beneficiaries and other stakeholders in monitoring and evaluation of the project. The process is aimed at assessing that the planned interventions have been executed in line with the intended objectives.

Performance Review of PME Teams:

With the formation of new Gram Panchayats and CBOs (WWMCs and RVCs), steps were also taken for the formation of new PME teams in the project Gram Panchayats. As can be seen from the table below, 100% PME teams have been formed in PMU Raipur covering all the





seven Gram Panchayats, followed by Pauri (92%), Thatyur 85% and Dehradun Division, Vikasnagar (64%). Overall, PME teams have been formed for Round-6 in 82% of the Gram Panchayats across the four divisions.

Status for formation of PME Team as on 31st March 2020

PME Methodology:

Before initiation of PME process in each GP, Gram Pradhans presented the records of GPs in front of Gram Sabha for their inspection. The Account Assistants of each Gram Panchayat presented the progress of works undertaken against the AWPs after previous Round of the PME with Audit report for the concerned financial year. Thereafter, the records regarding Project GPs were presented by Account Assistants who explained the importance of each document of Gram Panchayat being maintained by them. Formats R-1 and R-2 were shown by the Accounts Assistant and their utility was explained. R-1 is a broad report of the activity-wise monthly abstract of expenditure based on Integrated Activity Register, whereas R-2 is a monthly Beneficiary Contribution Statement. It is based on Beneficiary Contribution Register of the Gram Panchayat. Project Cash Book, Bank Pass Books, Sanction Registers, etc. were displayed of community consideration.





Progress of PME:

During FY 2019-20 PME Round-5 was initiated in Garhwal Region w.e.f. 2nd April 2019 and was completed in the month of July 2019 covering 199 GPs across the four Divisions. The date and time for conducting PME meetings was fixed in coordination with the Gram Pradhan and prior intimation for the same was well conveyed to all the PME team members and the community at large. During this period, PME meetings were conducted in 199 GPs across four Divisions of Garhwal region like Pauri, Tehri, Dehradun and PMU, MMWS, Raipur. Disputes in several GPs of Dehradun and Tehri Divisions were settled by village communities in implementation of project activities were revolved by devoting extra time. However, PME could not be conducted in three GPs, namely Samog, Unit Chakrata of Dehradun Division; Maugi Gram Panchayat of Nainbag Unit, Tehri Division and GP Gwad Malla, Unit Santoligad, Pauri Division on account of some dispute among villagers. Details of dates for conduction of Round-5 of PME are given in the Table below:

Sharing PME Outcomes:

Village community controlled the process for conduction of PME at GP level and result of the PME activities of entire GPs was discussed with the concerned authorities by FNGO team. Apart from this, the teams were engaged in identification of corrective measures for different activities which were implemented by the GPs till the date of PME. It was also observed that the PME teams were active in entire project GPs, and focused on quality of works done under their AWPs. After preparing the PME reports, the teams jointly agreed to share the results of PME with their respective DPDs for taking necessary action wherever required. Detailed report of PME Round-5 is already submitted to the Department.







FNGO Assistance in Other Activities

Visit of World Bank Mission:

World Bank teams visited village Dileu on 13th May 2019. After visiting various work sites, a community wide meeting was organized in Dileu and team members held discussions with the village community. During these discussions with the village community, information on VGs, FIGs and other activities was shared. Village community also shared their experiences and progress of project activities.



On 4th May 2019, World Bank Mission visited villages Thano, Dhaksari, Sindhwalgaon, Chak Sindhwal and Dharkot. In the village meetings, the team took up discussion on manpower and livelihood. In village Dhaksari and Sindhwalgaon, villagers told the team that 92 laborers are registered with the Labor Department. It was also informed that equal wages are paid to men and women laborers through the project.



In village Chak-Sindhwal, World Bank Mission visited 4-hectare horticulture site of Mr.





Kushalpal Singh, where he has planted different fruit trees of Pomegranate and Peach etc. In village Dharkot, the team visited fruit processing unit of women in Dharkot.

Visit of World Bank Mid-Term Review Mission:

ii) Village Lalotana: During the visit of village Lalotana, the World Bank MTR Mission inspected the site of vulnerable activities and interacted with the beneficiaries. In one such review, the Income Generating Activity (IGA) of Mr. Ram Das, who was provided with improved breed of Sirohi goat was inspected. The team also reviewed the IGA of another beneficiary Smt. Pramila Devi and interacted with her. The team also reviewed the records of the beneficiaries.



iii) Village Khyarsi: The World Bank Team went to village Khyarsi on 24th August 2019 and inspected various activities of project such as Solar Pumping Scheme, un-irrigated land converted into irrigated land for vegetable cultivation, Animal Shelter, backyard poultry farm Vanraja and the Growth Centre. The Growth Centre was well stocked with various local agricultural products displayed by the Federation for sale.

iii) Punah Pokhri: On 30th August 2019, the World Bank MTR Mission visited the sites of Gram Panchayat Punah-Pokhari. First of all, the team visited various project sites and physically verified the status of activities like afforestation, Irrigation tanks, Animal Shelters, Growth Centre, Polyhouse, Orchard, Rural roads and Income Generating Activities of vulnerable beneficiaries.

iv) PMU Raipur: On 29th of August 2019, World Bank MTR Mission visited the villages of the PMU like Dhaksari, Dharkot and Thano. The World Bank Team visited the site of hydroponics, vegetable cultivation and production, fodder production, irrigation tank, polyhouse, vermi compost, animal shelters, chili and pea cultivation, Napier grass and Goatry of Smt. Pushpa Devi and held discussions with User Groups





Collection Centre at Dharkot: Besides these activities, the World Bank Team was shown three specific activities in two locations. At Dharkot, they visited Collection Center where local women are running bakery and food processing centre.



Growth Centre at Thano: At Thano, the World Bank team visited the Growth Centre and witnessed the activities there. After inspection of all the machines established at the center, the team checked the records of Federation and held discussions with Federation office bearers on their roles & responsibilities and maintenance of records.

Assistance in Organisation of HARELA:

To promote awareness among villagers towards environment conservation, project staff prepared a strategy to involve villagers in mass plantation activities.



As a result of these efforts, women participated in plantation of various varieties of fruit trees like lemon and gooseberry etc. on mass scale. Villagers of Badoli, Dhoor, Gadari, Melgaon, Veena Malli, Saknoli, Halai Malli, Binjoli, Maletha, Latibau, Pokhada, Chaumasudhar, Malai, Gorli, Patal Gunth, Simar, Uchhakot, Bamoli, Ghandiyal, Chhimlidhang were mobilized for planting various fruit trees in their respective villages. Barren land was selected for plantation activities. The plantation activity will increase the biomass and improve water conservation to help the recharge of ground water.





Field NGO facilitated the mass campaign for plantation of fruit saplings in nine project villages, i.e., Upper Talai, Chitod, Sindhwal Gaon, Kairwan Malkot, Nahi Khurd, Kotala, Dharkot, Baderana Manjhla, Sangaon who participated in massive plantation programme. During plantation, villagers planted various fruit saplings of Lemon, Pomegranate, Mango, Jackfruit and Gooseberry (Anwla).

Activities Under Convergence Programme:

i) Transhumant Population:

Van Gujjar: on 22nd June 2019, a visit was organized to Kalsi Forest Range, where Van Gujjars have permanent camps (Deras) comprising 8 families. During the meeting with Van Gujjar family members in Kalsi Forest Range, they made a request for a teacher who can teach their children at their Dera itself. FNGO Convener, Coordinator and Facilitator convinced them to send their children to nearby Government Primary Schools in Kalsi. The field staff was accordingly instructed to follow up the matter and ensure that the children are admitted to the nearby Primary School.



Awareness among Van Gujjar families: Eight families of Van Gujjars are permanently settled in Kalsi Forest Range of Gram Panchayat Jonkla. They know well about the project activities which were carried out to the benefit of transhumant population under Transhumant Action Plan. They appreciated the efforts of project which were taken for their better human and animal health as well as the education of their children. Project has provided various utility items to Van Gujjars, such as, tarpaulin, tubs, torches, medicines and buckets etc. The project has also provided solar light for their Dera installed near their dwellings.

Health and hygiene: FNGO field team discussed about the health and hygiene of the Dera members. It was informed that they are taking the services of CHC, Kalsi. The surrounding areas of the Dera and houses were found to be clean, which points towards the awareness among transhumant population towards hygiene and sanitation.





ii) Distribution of Paddy Seeds by KVK:

During the FY 2019-20, 12 HHs of Gram Panchayat Vyasbhud were selected for demonstration of hybrid paddy seeds. FNGO field teams motivated and mobilized 12 local families to cultivate hybrid paddy seeds and converged them with KVK. The scientists of Krishi Vigyan Kendra (KVK) provided 20 kilograms of hybrid paddy seeds to 12 households for 1 bigha land of each beneficiary. The KVK Scientists also provided technical know-how to farmers on sowing.

iii) National Rural Livelihood Mission (NRLM):

NRLM is focusing on formation of groups of women to engage poor rural women in livelihood activities. The FNGO teams talked to Gram Pradhan Haripur, Tilwadi and Vyasbhud and conducted meetings of women with them. NRLM has selected Gram Pradhans of these GPs to form the group of women for livelihood activities. FNGO teams provided detailed information about NRLM to women. To form successful group of women, NRLM will give Rs. 20,000.00 to each group comprising of 7 to 10 women members to set up their livelihood activity. In case the performance of the group is found to be upto the mark, NRLM will increase the amount of such livelihood group. Till date, NRLM has formed total 7 women groups in these Gram Panchayats.

Field Visit of Sutra Team:

The representatives of Sutra, the external consulting Agency visited various villages like Kheda Malla and Talla, Lalotana, Tikri, Kandajakh, Matholi and Khyarsi and held discussions with beneficiaries of the project. The team checked the records and registers of vulnerable individual and group beneficiaries, User Groups, FIGs and RVCs etc. Apart from this, the team of Sutra held discussions with the beneficiaries of demonstration works such as poly houses, compost pits, mangers. etc.







FNGO field teams of Pauri Division provided assistance to SUTRA in village Rainsoli during the field visit on 12th May 2019. First of all, the team visited the horticulture site and raised questions related to area of horticulture land and byelaws for maintenance of orchard. The Villagers provided information about Goatry, milch cow and federation and satisfied the queries of SUTRA investigators.

In village Jhalpadi, the SUTRA team enquired about the project activities and their benefits to villagers. Special attention was paid on the progress of Mass Artificial Insemination. During meeting with the villagers, the teams took up the discussion on mass artificial insemination and provided knowledge about the breed of Jersey cow. They informed that the use semen of Jersey cow will give 100% female calves.

In village Jaitoli Malli and Talli, the team took up the discussion on the benefits of various activities of the project and checked the records of beneficiaries of poly-house, orchard, sewing machine, and milching cow during the meeting on 10th May 2019.

On 17th May 2019, the team visited village Kagtun and asked lot of questions on Vulnerable Group/Individual activities, such as, poultry, flour mill, general store and solar pump. Besides these, utilization of irrigation tank, tailoring and cultivation of mushroom and the benefits of these activities were discussed. On 19th May 2019 the team took up discussion on animal shelter, rain water harvesting tanks and functioning of Farmer Interest Groups (FIG) In village Gorli. Apart from this, the team checked the records of vulnerable group beneficiaries.









Facilitating Field Visit of National Hydrological Agency, Roorkee:

On 4th May 2019, a team of National Hydrological Agency, Roorkee visited Gram Panchayats Khyarsi, Chamasari and Buradi. The team took up discussion on protection and rejuvenation of water springs with villagers. The villagers informed that if the work for creating irrigation facilities is taken up in the villages, their un-irrigated land can be converted into irrigated fields.



Assistance in UNDP Field Visit:

On 6th May 2019, a team of United Nation Development Programme (UNDP), New Delhi visited Gram Panchayats Khyarsi and Bhatoli. FNGO Coordinator and Facilitators assisted in interviewing 10 villagers (5 males and 5 females). During the interview, the villagers were asked questions on climate change and its effect on their lives, cultural activities, crops and crops rotation, livestock, food habits, forest and wild animals. Villagers shared their experiences on these issues with the team.





Field Visit of IFS Probationers:

During this month, Forest Research Institute (FRI), Dehradun sent a team of 90 IFS Probationers for micro planning in MMWS, Thano, Raipur. IFS Probationers were divided into three teams – Tangoligarh, Dharkot and Kuthar. On the **First day** FNGO Facilitators and Coordinator provided information to IFS Probationers on GPWDP and PRA tools for micro





planning, which included transect walk, wealth ranking, matrix scoring, social and resource mapping etc.



On the **second day**, the team learned about data analysis based on PRA and prepared micro plan of Tangoligarh, Dharkot and Kuthar.

On the **third day**, teams visited Dhaksari, a project village and saw various activities undertaken through the project in the village. The project officials discussed about the Drain Line Treatment (DLT) works of the project and IFS Probationers observed various soil and water conservation structures and learned about them. At the end of the training, group discussions were held with IFS Probationers on works and problems of project area.

Field Visit of WMD officials:

Senior officials from WMD, Dr. Kavi, Dr. D.S. Rawat and Dr. S.K. Singh visited the project villages on 27th April 2019. During the field visit; the FNGO team facilitated the process and provided support in conducting the field visit. The team saw irrigation tanks, HDPE pipeline, Goatry and pomegranate orchards and found good survival rates of plants.







Exposure Tours:

An exposure tour of local villagers of Masras was organized on 27th and 28th April 2019 to KVK, Dhakrani. During the exposure tour, Sonika Chauhan, an expert of KVK provided simple information and knowledge to the villagers on floriculture and grafting of flower and Kagzi lemon. Besides this, KVK experts provided information on growing seedlings of various vegetables and promoting vegetable cultivation in the area.

Assistance in Tour to other Division:

- i) Almora Division: A team of villagers and progressive farmers visited the Growth Centre at Khyarsi on 18th September 2019. During visit to the Growth Centre, farmers were shown various activities of Growth Centre like poultry, goatry (Sirohi and improved breed Goat), vegetable cultivation, soil conservation works and other income generating works like pickle, oil, spices, pluses, juice, etc.
- ii) Rudraprayag Division: A team of famers from Rudraprayag Division also visited Growth Centre at Khyarsi and learned various things about the Growth Centre and held discussions with Federation members.



NDRI, Karnal, Haryana: An exposure tour of farmers from villages of Kandalinadi was organized for National Dairy Research Institute, Karnal, Haryana. As per the feedback collected by the FNGO staff, the exposure tour had been quite useful for the participants and they learned about breed improvement in milch animal and making of various daily use products from milk.

Jain Irrigation Systems Ltd.: During the month of November 2019, the FNGO Field Coordinator, along with other progressive farmers of Tehri division, participated in an exposure tour organized for **Jalgaon**, **Maharashtra** from 19th to 24th November 2019. During the tour, the participants learned about various new things regarding farming of banana and pomegranate and Amrapali variety of mango.





The importance of drip irrigation to check wastage of water, especially in cultivation of vegetables and other high value crops was explained by experts. They also learned about sprinkler technique of irrigation. As per feedback received from participants, they learnt about new technologies in farming which can be successfully applied in our project area.

Exposure Tour to G.B. Pant University of Agriculture: An exposure tour for farmers was organised to G.B. Pant University of Agriculture, Pant Nagar, Udham Singh Nagar. During the exposure tour, participants from Dehradun Division were exposed to various agriculture related activities, such as, poultry, dairy farming, mushroom and vegetable cultivation, etc. University scientists provided technical know-how about rehabilitation and renovation of fruit trees. Apart from this, scientists of the University also provided information about the farmer Mela organized by the University.

Exposure Tour to Growth Centre: An exposure tour was organized to Khyarsi village of Tehri Division from 27th December to 29th December 2019. FNGO staff and other MDT members participated in the tour. Mr. Sundriyal, SDO, Thatyur Division provided information to participants on drainage line treatment and soil conservation works at Kyari. Thereafter, the participants visited various sites in village Khyarsi where project has constructed Growth Centre for Farmers' Federation (FF).







Verka Milk Plant, Chandigarh Exposure Tour: From 20th to 24th November 2019 an exposure tour was organized for local farmers of Kwansi and Chakrata units to Verka Milk Plant, Chandigarh. The villagers of Maletha, Dudhau, Khoi, Chandeu, Sairi, Indroli, Baniyana, Mindal, Kurad-Khanad, Sawara and Tikri Khera participated in the tour. During the tour they learned about the dairy programme and various products made from milk, such as, Kaju, Pinni, Ghee, Kulfi, Ice-cream etc.

Growth Centre - Khyarsi: In Dehradun Division, an exposure tour for farmers was organised to see the works done in Growth Centre at Khyarsi. Participants learned about the activities taken up in the village like poultry, Goatry and management of Growth Centre. The objective of this tour was to learn about the management of Growth Centre. Division has proposed construction of Growth Centre at GP Punah-Pokhari, in Kwansi Unit.

Ranichauri: FNGO team of PMU, Raipur provided assistance in organizing exposure tour to Ranichauri. During the tour, participants saw the off season vegetable cultivation in the campus of G.B. Pant University of Agriculture and Technology, Ranichauri. Facilitators collected the feedback from participants who shared the learning of exposure tour with them.

NDRI Karnal, Haryana: In Dehradun Division an exposure visit was organized by units to National Dairy Reasearch Institute, Karnal for increasing the understanding of farmers in animal husbandry and other related income generating activities.

FNGO team of PMU, Raipur provided assistance in organizing exposure tour to National Dairy Research Institute, Karnal from 10th to 14th February 2020. The main objective of the tour was to learn about animal husbandry. The exposure tour was participated by 22 farmers from different villages of the division. During the exposure tour, the participants learned about improved breed of animal and dairy products.

Mass Artificial Insemination (MAI):

To improve the breed of cow, the project started Mass Artificial Insemination (MAI) in local cows with the assistance of Animal Husbandry Department in Ekeshwar and Pokhda blocks of Pauri district. A team of veterinary Doctors checked the pregnancy of cows which were artificially inseminated during previous months. During these pregnancy tests conducted in various villages, Veterinary Doctors informed that in maximum cases of artificial insemination, the cows have conceived. However, in very rare cases, they may not get conceived. In such cases, another chance to conceive her is taken when she again comes in heat. Apart from this, Artificial Insemination was also carried out in some villages like Veena





Malli, Ginwali and Odgaon. Total 167 cows of 32 villages in Pauri district got Mass Artificial Insemination by Animal Husbandry Department.

Assistance Provided in Trainings:

Pauri Division

- Training on Basket Making: In Pauri Division, Training was imparted to the villagers during the month of October and December 2019 on Ringal basket making. As per the feedback collected by the FNGO staff, training had been quite useful for the participants and they learned making various daily use items like tea coasters, mats for Pooja, sandal, pen stand, garland, tops etc. from Ringal.
- Training on Mushroom cultivation: On 24th and 25th January 2020, training was imparted on mushroom cultivation by Mr. Abhishekh to villagers.





- Goat Rearing: Another practical training was imparted on Goat rearing in Haridwar by Uttarakhand Sheep and Wool Development Board from 23rd to 25th October 2019. From this training, the participants gained practical knowledge on goat rearing.
- Training on Candle Making: From 2nd to 4th January 2020, training was imparted villagers by Km. Anjana Negi on soap, candle and agarbatti making at Metakund, Patisain.
- Training on Tailoring: Training was imparted by Km. Anjan Negi to villagers on tailoring in village Badeth and Satpuli from 10th to 29th January 2020,.

Tehri Division

Training on Candle Making: During the month of December 2019, the FNGO team of Thatyur unit of Tehri Division imparted training to villagers on candle making. The venue of the training was at Khyarsi Growth Centre. The beneficiaries learned about making 3 types of essence candles. Participants were of the view that the training was excellent and innovative in nature and provided them with new experience and opened up new





avenues of livelihood.



Training on Compost Making: During the month of December 2019, the FNGO field staff provided support in mobilizing and motivating villagers towards compost making. With the technical support of ABSO, Tehri, trainings were provided to farmers on compost making in villages Bel, Sarab, Beeragaon and Banglo Ki Kandi. Under this technique, *trincho and tseudo* are mixed with one litre of water and sprayed on cow dung and covered with poly-sheets. For this method 2 quintal of cow dung is sufficient to make compost. After 20 days, cow dung is shuffled upside down and within 40 days the compost is ready for use.

Dehradun Division

Training imparted on Candle Making: Kwansi unit of the Division imparted training to villagers in 10 villages of the unit during this month on candle making. FNGO team of the unit mobilized the villagers for participating in trainings and as a result of this mobilization, the villagers participated in the training and learned about candle making.



Training on e-marketing: During this month, Kwansi unit imparted training to 25 persons from 5 villages, namely, Punah-Pokhari, Cidi-Barkoti, Kandoi-Baundur and Chhultad. Trainer explained to the participants the intricacies regarding e-marketing. Trainer also told farmers as to how they can promote their business through e-marketing sitting at





home. Besides this, Chakrata Unit also conducted a number of village level trainings in 12 villages of the project area during the month of November 2019.



- Button Mushroom Cultivation: During this month, Chakrata unit imparted training to villagers in villages Tikari Kheda and Dakra Kheda of GP Mohana on income generation activity. The training was focussed on cultivation of button mushroom.
- Goatry: Under convergence activities, FNGO team of Dehradun Division provided support on organizing training programmes for livestock breeders with support of KVK Dhakrani. 25 livestock breeders attended the training on goat rearing. Vetrinary Doctors provided simple and suitable information and knowledge to the farmers about Goatry, fodder and feed, control of disease, etc.
- Mask Making: Similarly, Ex-Pradhan of Gram Panchayat Haripur Smt. Rekha Devi imparted training to local women of village Haripur on preparing low cost masks. After training, women of FIGs prepared 1000 peices of masks. Women working on preparing Mask are given Rs. 5.00 per piece as their labour.

PMU (MWS) Raipur

Assistance in Soap, Candle & Dhoop Making Training: From 27th to 29th November 2019 a three days training was imparted to 10 local women of the project villages. Training was organized for villagers at the Division level which was attended by 45 participants from project villages, namely, Sangaon East and West, Thano, Kaknawa, Dharkot, Tangoligarh, Nahikalan, Sindhwalgaon, and Kuthar.

Method – Soap Making: First of all, the 100 gm base is mixed with 10 ml water and heated on Microwave for 2 minutes for melting. After the base has melted, color and essence is mixed as per the requirement. Thereafter, the mixture is put in to the mold and after 15 minutes, soap is ready for packing and sale in the market.





During the month of February 2020, the FNGO field staff provided support in organisation of various training programmes in the Division. Division conducted training on making candles and herbal colours from natural flowers. FNGO teams involved the federation members in making different colours for Holi from natural flowers at Khyarsi.



Method – **Candle Making:** First of all, Wax is melted on stove and color and essence is mixed with the solution as per the requirement. Thereafter the mixture of wax is put in to the candle mold. When candle gets hard, the tread is penetrated in to the candle with the help of needle/drill.

Method – **Dhoop Making:** All the ingredients are mixed and ground together and after obtaining powder a doe is made and different shapes can be given to make Dhoop.

Feedback: Feedback of participants was obtained on the trainings, who informed that the trainings on making soap, candle and dhoop were quite useful for them can be adopted as livelihood opportunity.

Training on Bakery: FNGO team of PMU, Raipur mobilized and motivated village women for training on making bakery products. The three days training was organised for rural poor women to provide them with skill on adopting alternative livelihood. Training was imparted by HESCO, Dehradun and women learned to make sweet and salty biscuits from maize and finger millet flour.



Feedback: Training was very useful for the women and Smt. Subhdra Devi and Smt. Malati Devi demanded for putting up a bakery unit at Dharkot with project assistance.







Workshop on Protection of Water Source:

A workshop was organised on 22nd June 2019 at Thano and FNGO team of PMU, Raipur mobilized and motivated the villagers to participate in the workshop. As a result of this, 45 villagers attended the workshop and participated in the discussions on protection of water sources in the project area. During the workshop, discussions we held on the importance of water sources.



Assistance in Organizing Stall:

Government of Uttarakhand organized cabinet meeting in Pauri Division Head Quarter on 28th & 29th June 2019. On this occasion, the stalls were displayed with various local agri-products, such as, turmeric, garlic, pickles, pulses, finger millet flour, Jhangora, ghee, tomato, capsicum and potato, etc. Kandoliya ground. FNGO Facilitators and Village Motivators played a very important role in collection, packaging and selling of these articles at



the stalls. During the exhibition, a total sale of Rs. 29,685.00 (Patisain Rs 12,515.00, Santoligaad Rs. 8,660.00 and Kandali Nadi Rs. 8,470.00) was made.

Assistance Provided in Organization of Exhibition

An exhibition was organised at Chaubattakhal which was inspected by the District Magistrate, Pauri District. For successful organisation of this exhibition, FNGO teams of Pauri Division facilitated the process and motivated the farmers to attend the exhibition.

FNGO team of PMU, Raipur provided assistance to farmers in organizing exhibitions at two locations, namely, Doon Expo and Conference of Presiding Officers from all over India. The details of which are as follows:

Doon Expo: Doon Expo was organized from 13th to 15th December 2019 at Parade Ground Dehradun. During the Expo, farmers displayed various local products, such as, Rajma, Urd, Tor, Gahat, Jhangora, Millet and Maize and other decorative items produced by them. Farmers earned an amount of Rs. 16,500.00 from sale of these products.







Conference of Presiding Officers from All Over India: PMU, Raipur displayed various local products and handicrafts during the Conference of Presiding Officers from all over India and earned Rs. 5,800.00 from sale of these items.

Visit of Project Director, Gramya:

Project Director, Gramya-II visited the project villages on 25th October 2019. During the visit of PD, Deputy Director and other project staff facilitated the process and held meeting in the Growth Centre at Thano with local farmers and members of Malkot Swayaat Sahakarita Federation (Malkot Autonomous Cooperative Federation) and instructed Federation members as follows:

- Preparation of monthly Action Plan of Federation
- Organization of regular Federation meetings at Growth Centre, Thano and preparation of their Business Plan.
- Conducted Market Survey for agriculture products received at Growth Centre

Project Highlights

"United We Stand"

Background:

The small and medium enterprises are best and successful sources to generate new livelihood opportunities in the rural areas. It is important that such enterprises are supported by proper skill development tranings to be provided to the beneficiaries before starting the enterprise.



To meet the objective of providing successful sources of livelihood to the eligible project beneficiaries, the project has taken up various types of skill development tranining programmes based on rural based enterprises, such as, agriculture, horticulture and off season vegetable cultivation etc. A number of women and youth have benefitted from these tranings in the project villages. Under this programme, training was provided to a group of women in Dharkot village of PMU Raipur for processing of local agriculture products. The Women Self Help Group which was later named as Maa Surkanda Mahila Samuh has set an example in generating collective livelihood in the rural area.





Maa Surkanda Mahila Samuh:

Maa Surkanda Mahila Samuh is a group of local women from Dharkot Gram Panchayat of PMU Raipur. During various village level meetings, wome had made proposals for providing them trainings on various livelihood activities, such as, fruit processing, mushroom cultivation, tailoring, etc. which were provided to these women through the project. Later a group named as Maa Surkanda Mahila Samuh was formed for initiating livelihood activities collectively. To start with, all necessary equipment for food processing and packaging, etc. were provided to the group. The group prepared various kinds of pickles which included, Turmeric, Mango, Goosebery, Green chillis, Ginger, Garlic and ficus Ariculata (timla) pickles, etc. took initiative in selling these products in the village, nearby market and several exhibitions organized at Prade ground, Doon festival, Spring Festival at Governer House and Forest Research Institute (FIR), Dehradun. Good demand of these products boosted the morale of group members and as a result, these women are successfully and self-sustainably running their enterprise.

In view of the success achieved by these women, the project has set up a collection centre on the land donated by the Gram Panchayat Dharkot during the current financial year. Eearlier, the group was functioning from the house of one of its members with lack of space and difficulty of working, but the collection centre provided ample opportunity to this women group to work independently with ease of working.

To add to their products, traning was also provided to the group on production of bakery products in August 2019 and later necessary oven and other bakery equipment were provided through the project. Bakery products of this group, such as maize, atta, quinoa and mandua biscuits have been well accepted by the market in various exihibitions.

Income of the centre:

In the month of February 2020, the FNGO team assessed the progress and income of the groups which was as follows:

Raw Material: Till the end of February 2020, the group had spent Rs. 39,170.00 on purchase of raw material procured from the market, as well as, locally available in the project area, against which they have made a sale of Rs. 95,570. 00

Net Profit: Thus, the group made a net profit of Rs. 56,400.00 after deducting the cost of raw material. During this month, the profit was divide among all the 14 group members @ Rs. 2800.00 each and the remaining amount of Rs. 17,200.00 has been deposited into group's bank account as principle amount for procuring raw materials in the future.

Materials Stocked: Apart from this cash amount, several ready products, such as chillis, gooseberry and ficus Ariculata pickles, biscuits, nuggets and Arssa sweets valued at Rs. 20,000.00 are also available in the centre for sale.



Managemnet of Centre: Now, the group has its own FSSAI Licence No. 22619024000385 which helps them to sell their products in the market. Due to this licence, they do not face any problem in marketing of their products. For better management of this collection centre, 2 women of of the group are kept on duty in rotation to look after the management and other activities of the centre.

As per the member of group Smt. Sumitra Devi – *Today, we are running our centre independently without any outside support. We are indebted to the project personnel for developing our capacities to enable us work successfully.*





"A New Inititative during Hard Times"

Background:

During the existing Coronavirus Scenario, women of a vulnerable group in village Vyasbhud have taken a new initiative in manufacturing of Masks and have prepared 1000 mask during the lockdown period and sold out the same to Jan Sewa Samajik Sansthan and have earned an amount of Rs. 10000.00 (Ten thousand only) from the same. Going a step ahead, they also distributed the masks prepared by them to Corona Warriors free of cost. This inititative has boosted up their confidence to further take new orders from the market for furtherance of their venture.



Saksham Silaai Samuh:

Saksham Silaai Samuh is a group of poor women from Vyasbhud Gram Panchayat of Sahiya unit, Vikasnagar. During various village level meetings, these poor women had made proposals for providing them trainings on various livelihood activities, especially on tailoring which can provided early and quick income opportunities to these women. The Group comprising of five women from vulnerable households was formed in the year 2017 for





undertaking tailoring as a collective livelihood activity. All women of the group come from poor and socially backward schedule caste category who had no viable options for earning a livelihood to enhance their household income. The group had received a grant of Rs. 1.00 lakh from the project for tailoring work. All necessary equipment required for tailoring were purchased and the work was started at a common place provided by the group President Smt. Seema Devi.

School Unform and ladies' suits: In the initial stage, the group members worked collectively and by the end of Feburary 2020, the group has made an earning of Rs. 59,059.00 (Fifty-nine thousand fifty only) from their enterprise after meeting their expenses. Again during this month, they have received an order of stitching 150 sets of school uniforms from local schools at the rate Rs. 120.00 per set. By mid-March 2020, the group income has reached Rs. 71,590.00 (Seventy-one thousand five hundred ninety only) through stitiching of clothes.

Preapring Mask: Due to the quality of their work, they received an order for preparing 1000 cloth masks from Jan Sewa Samajik Sansthan (JSSS) during lockdown period due to Covid-19 @ of Rs. 10.00 per piece of mask and earned Rs. 10,000.00 (Ten Thousand) from the same.

It was a new experience for the group members. Women of Saksham Silai Samuh completed their order in time and apart from making good profit from the venture also distributed the same free of cost to Police personnel engaged in Coronavirus duties. These women are also working on preparing carry bags made of cotton cloth. By the end of this month the total income of the group has reached Rs. 71,590.00 + Rs. 10,000.00 = Rs. 81,590.00. In case of increased demand and pressure of work they also engage skilled women to cope up with the work thus generating additional employment for the local women.

According to Smt. Seema Devi, Group President– Today, we are running our tailoring centre independently without any outside support. We have enhanced our skills and are taking various new intitatives like masks and carry bags, etc. for group sustainability. We are happy and thankful to Watershed Project for providing initial support in setting up our livelihood. We are developing our capacities to enable us and run our enterprise successfully.
